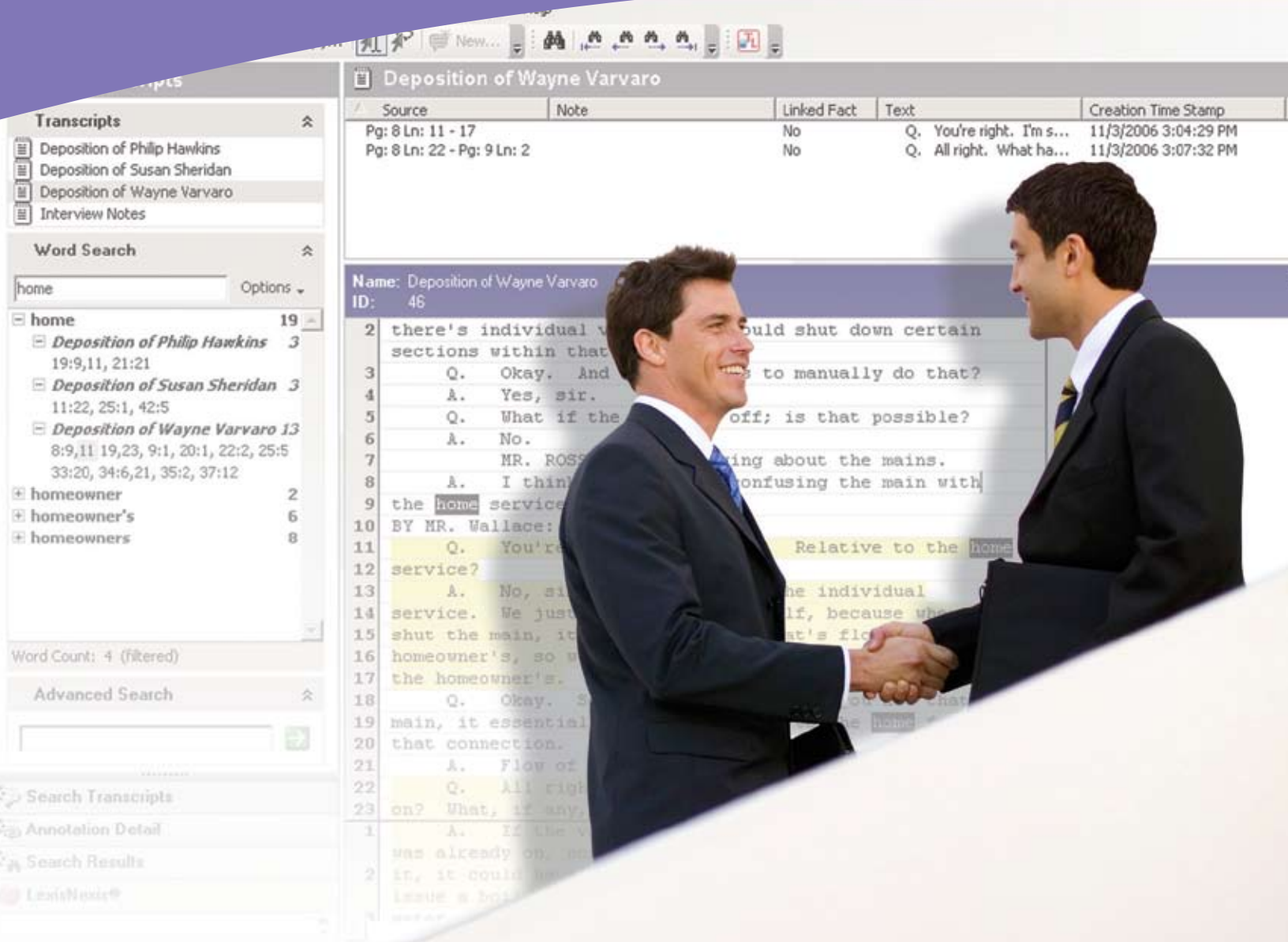

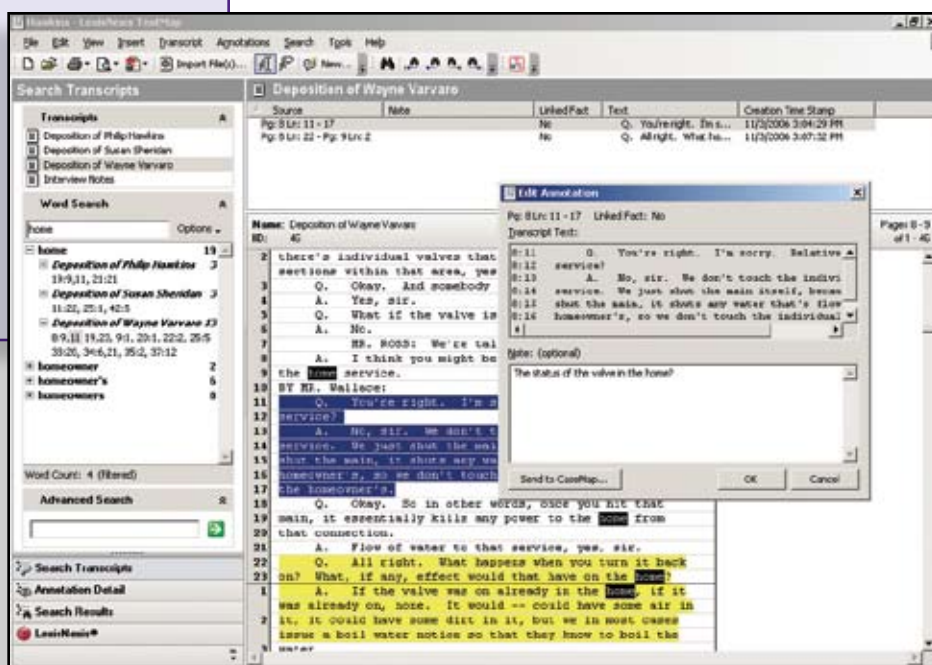

As transcripts are imported into TextMap, each transcript word is indexed and added to a transcript dictionary that also includes the number of times the word was used in all transcripts and a “hits list” showing the specific transcripts, pages and lines where the word appears. Generate Valuable Reports

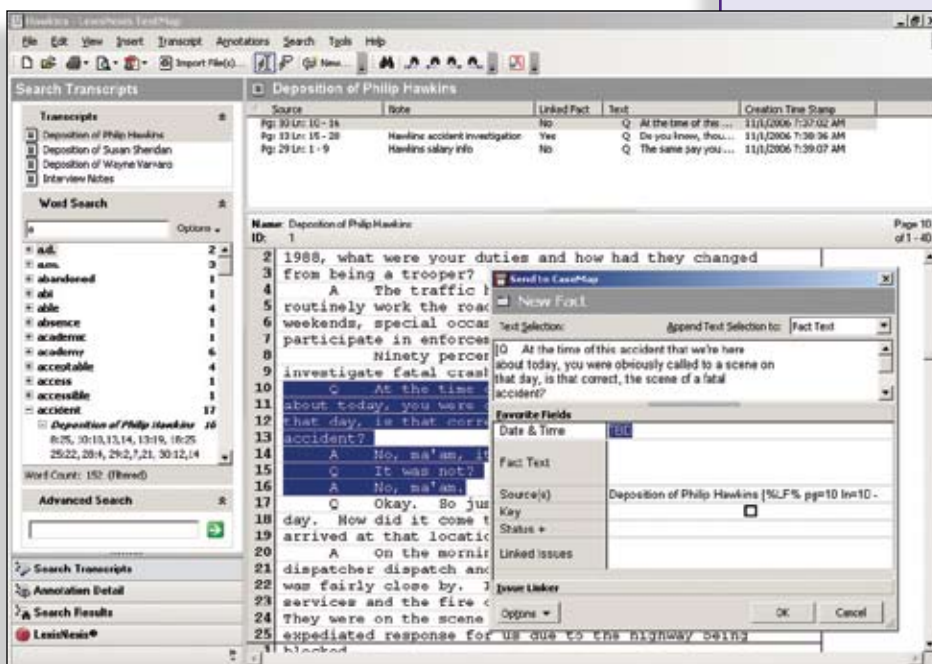
